
ARTICLE 7
MINUTES, RULES, ~~AND BUDGETS,~~ AND REPORTS

7.1 Board and University Documents.

(a) The Board shall provide the UFF with a written copy of the following:

- (1) the minutes of the meetings of the Council of Presidents;
- (2) the minutes of the meetings of the Board and its committees and subcommittees;
- (3) Board rules published under the Administrative Procedures Act; ~~and~~
- (4) copies of the ~~FBOE BOT~~/UFF Agreement and all supplements to the Agreement, consistent with the provisions of Section 28.5;
- (5) a copy of all Board policies and procedures;
- (6) the university's operating budget, including the previous year's expenditure analysis;
- (7) Average Faculty Salaries annual reports;
- (8) Salary Increase Worksheets for colleges, departments and units;
- (9) Stipend Summary reports; and
- (10) all reports described in Article 23 regarding all salary increases and monetary awards provided to employees.

(b) The Board shall provide the UFF with an electronic copy of the following:

- (1) the university's operating budget, including the previous year's expenditure analysis;
- (2) Fall Staff Reports;
- (3) Faculty Activity cumulative reports and updates; and
- (4) all reports described in Article 23 regarding all salary increases and monetary awards provided to employees.

(c) The Board shall also provide the UFF a computer account, or accounts if necessary, for purposes of accessing the State University Personnel Employee Records System file and other computer files reflecting the annual salary increases and monetary awards provided to employees and employee activities. Costs associated with the UFF's use of such files shall be borne by the UFF consistent with the costs charged others using the State University System Personnel Employee Records System and other computer files.

- (1) minutes of the meetings of the Council of Presidents;
- (2) the minutes of the meetings of the Board and its committees and subcommittees;
