ACCESS TO INFORMATION

7.1 Board and University ~~Documents~~ Information.

(a) The Board shall provide the UFF with a an electronic or written copy of the following:

- (1) the minutes of the meetings of the Council of Presidents;
- (2) the minutes of the meetings of the Board and its committees and subcommittees;
- (3) Board rules published under the Administrative Procedures Act; ~~and~~
- (4) copies of the ~~FBOE~~ BOT/UFF Agreement and all supplements to the Agreement, consistent with the provisions of ~~Section 28.5~~ Article 28;
- (5) a copy of all Board policies and procedures;
- (6) the university's operating budget, including the previous year's expenditure analysis;
- (7) Average Faculty Salaries annual reports;
- (8) Salary Increase Worksheets for colleges, departments and units;
- (9) Stipend Summary reports; ~~and~~
- (10) Fall Staff Reports;
- (11) Faculty Activity cumulative reports and updates;
- (12) all reports described in Article 23 regarding all salary increases and monetary awards provided to employees; and
- ~~(14)~~ (13) Within seven (7) days after any request, upon request within seven (7) days, any other information necessary to administer grievances and other provisions of this Agreement or otherwise carry out UFF's obligations as the certified bargaining agent for the employees.

(b) All materials or access shall be provided without cost.

~~(d c)~~ The Board shall also provide the UFF a computer account, or accounts if necessary, without cost for purposes of accessing the State University Personnel Employee Records System file and other computer files reflecting the annual salary increases, ~~and monetary awards~~ provided to employees, and employee activities. ~~Costs associated with the UFF's use of such file shall be borne by the UFF consistent with the costs charged others using the State University System Personnel Employee Records System.~~

~~(b-d)~~ The Board shall ensure that a copy of the following documents is made available in an easily accessible location in its the main library or by links on the university web site:

- (1) minutes of the meetings of the Council of Presidents;
