The meeting came to order at 10:33am

- 1. **Minutes**—Stan Smith moved to accept the minutes as presented; Jim Gilkeson seconded. The motion passed unanimously.
- 2. President's Report (S. Park for K. Seidel):

Shelley reported the various items to be included on the consultation agenda: intellectual property, TIP/RIA revision, Conflict of Interest/Outside Activities, parking fees, side parking lot next to the new Music building needs a sidewalk, administrators serving in faculty governance

The consultation is not yet scheduled

K. Seidel is meeting with the provost; at this meeting, she will address concerns about the new requirement that administrators be listed as Co-PI on all grants, and partner benefits

September 16-17 is the State Senate meeting; must reserve by today

Barbara Fritzche, Claudia Schippert and Shelley Park have confirmed their intention to attend Proxy forms must be completed for those not attending and given to those who are attending. The proxy form is on the UFF site.

The next State Senate meeting is February 17-18, 2012.

The following persons were recognized: Claudia Schippert, return from sabbatical, Steve Chicurel, who is off on sabbatical, and Terri Fine, who will be serving as Secretary.

Rudy McDaniel is now out of unit; K. Seidel will seek clarification as to why Rudy's new position is out of unit

The membership drive continues—good efforts to contact new faculty; 90+ people at the welcome reception

Motion: Stan Smith moved that UFF give a donation of \$250 to the Burnett Honors College to thank them for hosting the UFF welcome reception. Claudia Schippert seconded. The motion carried unanimously.

UCF-UFF membership is presently at 30%; the state UFF goal is 55%.

Michael Moats announced that next year's legislature may decertify any union chapter with less than 55% membership;

UFF may lose deduction rights

The FEA needs defined, measurable, achievable goals in order to pump resources into a chapter The groundswell of any membership effort must be September through November; once Thanksgiving comes, faculty are busy, and we need faculty to knock on doors

Beth Young suggested that retired faculty might be good recruiters

The next item discussed was the Chapter Playbook and strategic plan Beth Young revised the recruiting document and introduced it as a two page document; Jason Martin also participated in this effort

3. Treasurer's Report (S. Smith):

We are in good shape.

Motion: Dawn Trouard moved that Donna Malvey and Jason Martin design an electronic suggestion box; Keith Folse seconded. The motion carried.

6. **Bargaining Report** (J. Gilkeson):

Kathy Seidel and Jim Gilkeson are going to each college with Sherry Andrews and Charlie Piper with the focus on implementing Article 10

8. **Old Business** (S. Park):

Stipends/ADI report: \$350,000; 1% cap. The administration had \$1,000,000 to spend and they spent about 1/3 of it

S. Park asked where AFSCME could get bulletin board space; there was no consensus, and the belief was expressed that UFF-UCF does not have a dedicated bulletin board.
