 - ii. Article 16 Disciplinary Action and Job Abandonment
 - iii. Article 19 Conflict of Interest or Commitment/Outside Activity
 - iv. Article 21 Other Employee Rights (which remains unchanged from the current CBA)
- c. Both parties now have tentatively agreed on 16 of the 32 contract articles, plus the Preamble
